2. **COMPOSITION / INFORMATION ON INGREDIENTS**

Erasers are made from TPR.

3. **HAZARDS IDENTIFICATION**

There are no known hazards applicable although may be perceived as a choking hazard if swallowed.

4. **FIRST AID MEASURES**

Product is non-toxic and therefore there are no specific first aid measures applicable. However if swallowed seek medical advice as a precautionary measure.

5. **FIRE FIGHTING MEASURES**

In large quantities the Manufacturer is trained in relevant fire extinguishing procedures and evacuation procedures as a precautionary measure.

6. **ACCIDENTAL RELEASE MEASURES**

No relevant information as product is considered non-hazardous.

7. **HANDLING AND STORAGE**

No special conditions for storage although should be kept out of extremely hot temperatures.

8. **EXPOSURE CONTROLS / PERSONAL PROTECTION**

In production avoid frequent or prolonged contact with skin and wear the appropriate protective clothing i.e. gloves, masks, eye protection etc. In small quantities no exposure control procedures are deemed necessary.

All elements are within guidelines and comply with section 3 (migration of certain metal elements) of EN71 on Toy Safety.
